Tri-State Citizens Mining Network unveiled its new name: **Center for Coalfield Justice**. Dedicated to working for community justice in western Pennsylvania's coalfields, we have been organizing around coal mining impacts on communities and the environment since 1994

"The Center for Coalfield Justice is a new name that reflects the need to take a more comprehensive look at impacts of coal mining in our communities," explained Jim Kleissler, the new Executive Director for the organization.

As part of the organization's facelift, the Center for Coalfield Justice launched a new website at www.coalfieldjustice.org. The new website, among other things, features a blog, a mediawiki page, and a sign-up for the organization's *Coalfield Review* e-mail newsletter.

"Industrial mechanized coal mining practices have a pervasive effect on our communities, homesteads, farmland, and our natural environment," explained Mimi Filippelli. "In

order to better reflect the work that our community organization is doing, we changed our name to Center for Coalfield Justice."

In addition to changing its name, the organization welcomes two new staff members. Jim Kleissler is the new Executive Director, and Rebekah Weigel is the new Community Organizer. The organization has a long history of doing public education work and providing assistance to homeowners impacted by coal mining operations. The organization is known for its lobbying efforts, protests, and community forums.

"I joined the Center for Coalfield Justice because I believe that our communities have a right to a reasonable quality of life without having our businesses and home lives disrupted by coal mining operations," said Rebekah Weigel, the Center's Community Organizer.

DRYerson Festival at Ryerson Station State Park

Ryerson Station State Park has been home to fishermen and boaters until damage to the dam caused the park to drain Duke Lake in July of 2005. The lake, once holding warm-water game fish still has not been repaired.

Although mining has not been established as the only cause of the crack in the dam, which led to the draining of the lake, it has been established as a significant cause of the damage. This lake once contributed to a major source of recreation provided by Ryerson Station State Park. Now, it is nothing but an empty lake bed. Although the lake is already drained, we, as a community, can still show our disapproval of the mining companies taking over our land, our communities, and the recreational places we share with our families.

Please join the Center for Coalfield Justice as we raise awareness of what happened to Duke Lake in Ryerson Station State Park. We will be holding our **DRYerson Festival** with games and activities for families and community members on June 2nd from 11-2pm, to show that we will not stand for more damage done to our land and our communities.

Coal Bed Methane (CBM)

Coal Bed Methane (CBM) extraction is an issue with which the Center has recently become involved. What is CBM? Simply put, it is primarily methane gas trapped within coal seams. When plant material is converted into coal, methane gas is created. This gas is bonded to the coal surface by pressure from overlying rock, soil and the surrounding water table. CBM can be extracted from coal seams and used for energy.

In order to efficiently produce CBM, a well must be drilled. There are several types of CBM wells including: vertical well producing from one coal seam, vertical well producing from several coal seams, vertical well drilled into one coal seam with a series of horizontal bores extending out through the coal, all producing from the same seam, vertical well drilled through multiple coal seams with laterals completed in and producing from these seams, and former gob gas vents converted to CBM production.

What are your rights? If you do not own the coal rights to your property, you do not own the coal bed methane. Many companies practicing coalbed methane extraction assert that they have the absolute right to do what they please with your property in the process of constructing and operating methane wells. Many attorneys familiar with the issue, however, believe this not to be true, and believe the company's approach MUST BE REASONABLE, with property owners having several rights.

Be sure to request a copy of the permit application from DEP for a well that is to be installed on your property. You are entitled to this! Also, to read some agreements (both good and bad) negotiated between CBM companies and private landowners, visit our website (go to www.coalfieldjustice.org/wiki and click on CBM).
